Bill Heckley called the meeting to order at 6:00 p.m.

Bill Heckley reminisced about former Board Member, Jack Bledsoe, who passed away recently. Bill Heckley, on behalf of all Board Members, thanked Jack Bledsoe and his family for his service and dedication on the Board. He will be missed by all.

Bill Heckley welcomed newest Board Member, Harry Krebs, to the District.

Tim Frederick presented a shortened film presentation ("Drop by Drop Protecting Indiana's Water Supply") sent by the State Water Quality and the State Sewer District to be reviewed by the Board and the audience members.

APPROVAL OF OCTOBER 14, 2010 REGULAR MEETING MINUTES CHANGES OR ADDITIONS

Minutes of the October 14, 2010 meeting were presented for review and approval by the Board. Upon motion made by Jim Kidd and seconded by Bob Coder, the Board unanimously approved the minutes of October 14, 2010. No meeting was held in November.

FINANCIAL REPORTS

The financial reports, check register, project check register, bank account report, and claims, were presented for review. Jim Van Vlerah moved and Bob Coder seconded the motion to accept the Financial Reports (November 10, 2010, and December 9, 2010), as presented, which motion was unanimously approved.

NEW BUSINESS

Waggoner's RV Park Requests Credit for Water Leak - Tim Frederick stated that there was a water leak and a credit should be given. Lyndon Tucker moved and Jim Van Vlerah seconded the motion that \$145.52 be credited to Waggoner's RV Park for the water leak, which motion was unanimously approved.
